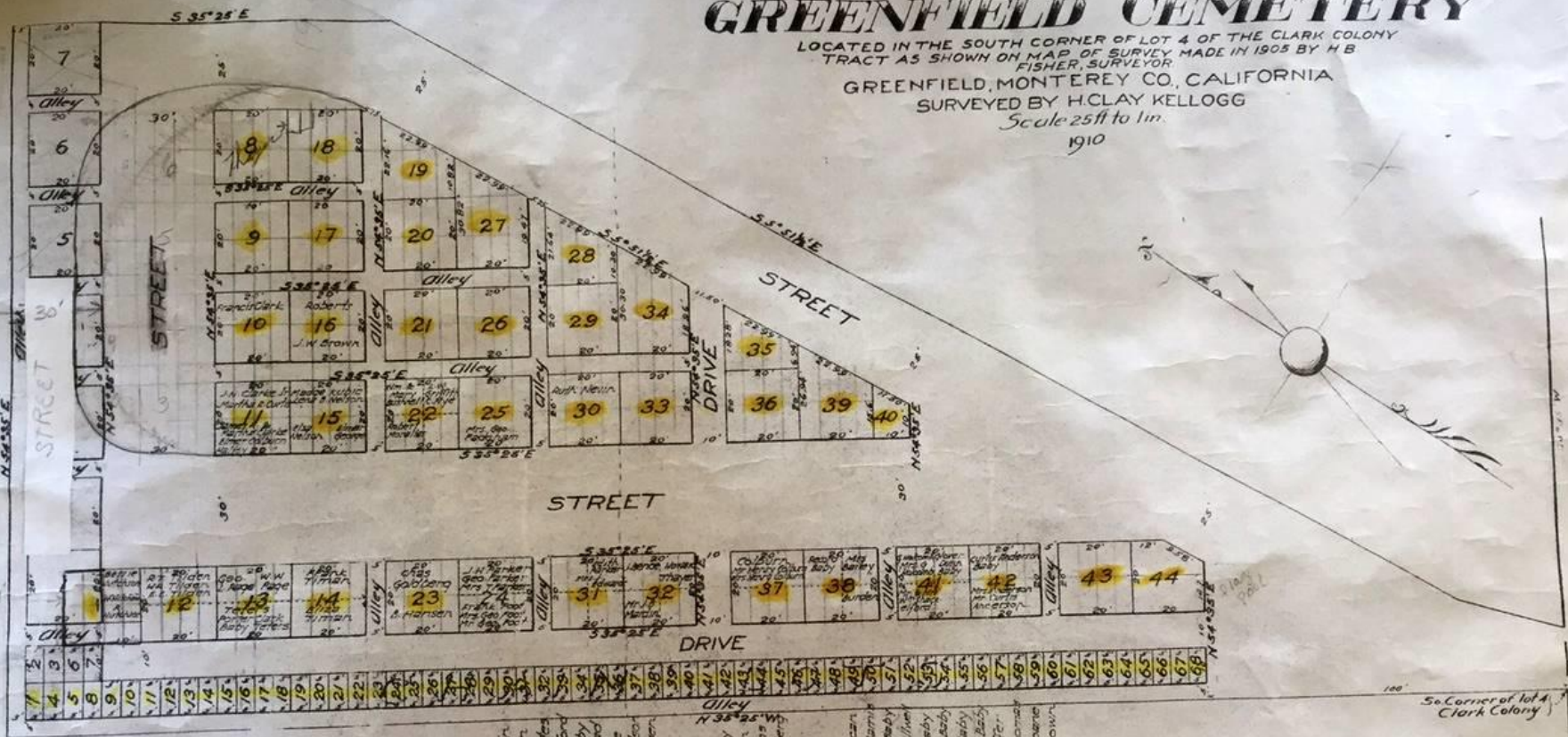


# MAP OF GREENFIELD CEMETERY
